### Important Guidelines for admission in 5-Year B.A.LL.B. Course 2024.

1. Students /candidates are required to produce or submit correct information or documents.
2. If any information, given by the candidate/student or anyone on behalf of the candidate /student, found incorrect then the student/candidate will be responsible for consequences which may lead to cancellation of candidature of that student/candidate for Admission to 5-Year B.A. LL.B. Course.
3. Students who wish and applied to avail RESERVATION of SC, ST, OBC-A, OBC-B, PWD or EWS for the Admission to 5-Year B.A.LL.B. 2024 have to submit CERTIFICATE / DOCUMENTS from competent authority as per Government Rules and Orders during ONLINE FORM FILL UP and PHYSICAL DOCUMENT VERIFICATION for 5 Year B.A.LL.B. Admission process when and where may be required by the University of Calcutta/College.
4. Students will be responsible for any incorrect information/non-submission of documents/non-presentation of documents at the time of physical verification/incorrect documents submitted/incorrect documents produced by them at any point during admission process and that may be the cause of cancellation of Admission and Registration as per the Rules of University of Calcutta.
5. The Authority of University of Calcutta/College will not be responsible for any incorrect data uploaded online or produced physically by the candidate / student for the purpose of Admission process, E-counseling, E-payment (where applicable) for the admission.



Following documents both **Original** and **1 set photocopy (for submission)** in following order to be brought for Physical verification of documents. Non-submission/non-presentation of documents at the time of physical verification may be the cause of cancellation of Admission and Registration as per the Rules of University of Calcutta.

1. Admission Slip & CULET-UG Hall Ticket, 2024.
2. EWS/SC/ST/OBC-A/OBC-B Certificate (Wherever applicable). Applied for Certificate will not be considered as per guidelines of University of Calcutta. EWS Certificate issued for the accounting year 2024-2025. Issuing state must be West Bengal and only from competent authority as per Government Rules and Orders.
3. PWD Certificate (Wherever applicable). Only from competent authority as per Government Rules and Orders.
4. Mark Sheet of 10+2 Level.
5. Aadhaar Card of the candidate.
6. Printout of application form filled in the online format in the college portal.
7. Printout of receipt of the amount of Rs. 4580/- paid at the time of filling online admission application.
8. Anti-Ragging affidavit or Anti-Ragging Online Undertaking.

All students of First Semester are to submit the AFFIDAVIT or ONLINE UNDERTAKING in context to ragging issues. The guidelines for doing the same follows as below.

### **Guidelines for filling Anti Ragging Undertaking**

In pursuance to the Judgment of the Hon'ble Supreme Court of India dated 08.05.2009 in Civil Appeal No. 887/2009, the UGC has notified Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009. As per UGC Regulation on Curbing the Menace of Ragging in Higher Educational Institutions (Second Amendment) 2013, all the students taking admission to First Semester will have to submit ANTI-RAGGING AFFIDAVIT or ONLINE ANTI-RAGGING UNDERTAKING. The submission of Affidavit or Online Undertaking is mandatory for all students.
